To implement the indicators, select 'New Indicator ...' from the 'Insert' menu and use the Indicator Wizard to create the following indicators:

LR: Sub(LinTimeReg PredValue(Close,50,0),Close)

MLTP2: Mul3(3,SimpleStoch%K(LR, 50),0.01)

RATE: Mul2(Divide(2,Add2(1,51)),Add2(1, MLTP2))

LRAdj EMA: DynamicExpAvg (Close, *RATE*)
