The expert trading system described by Sylvain Vervoort can be easily implemented with a few of NeuroShell Trader's over 800 indicators. Simply select 'New Trading Strategy ...' from the 'Insert' menu and enter the following in the appropriate locations of the Trading Strategy Wizard:

Generate a buy long order if all of the following are true:

And2(A>B(ExpAvg(Avg3(High,Low,Close),5),ExpAvg(HeikinAshiClose(Open,High,Low,Close),8)),A>B(Close,Open))

Generate a long protective stop order at the following price levels: PriceFloor%(Trading Strategy.9)

EntryPrice%(Trading Strategy,10)

Generate a sell short order if all of the following are true:

And2(A<B(ExpAvg(Avg3(High,Low,Close),5),ExpAvg(HeikinAshiClose(Open,High,Low,Close),8)),A<B(Close,Open))

Generate a short protective stop order at the following price level:

PriceFloor%(Trading Strategy,9) EntryPrice%(Trading Strategy,10)

If you have the NeuroShell Trader Professional, you can also choose whether or not the parameters should be optimized. After backtesting the trading strategy, use the 'Detailed Analysis ...' button to view the backtest and trade by trade statistics for the strategy.
